What is ENCORD?

The European Network of Construction Companies for Research and Development (ENCORD) is a network of active members from the construction industry, represented by decision-makers and executives working on research, development and innovation (R, D & I). ENCORD has **20** members with head offices in 9 European countries and operations worldwide. All members are major European contractors and/or suppliers of construction material and are strongly devoted to R,D&I for increased competitiveness and growth.

The member companies are found regularly in the Top 50 European and Global Contractor lists and all together employ over 1.15 Million people and have combined annual revenue of over 200 Billion Euro.

The ENCORD "Council" is responsible for setting the ENCORD strategy and is a forum for discussion and debate on R&D priorities and the development of the construction sector. The Council also discusses common research issues, European R&D funding and project proposals.

Participants represent the whole European research community, including construction companies, suppliers, end-users, research institutes and universities.
